- Tuition: Tuition is due on the 1st day of each month. A late fee of \$10 will be assessed after the 8th. USG sends out monthly billing statements by email upon request. You are responsible for timely payment of your tuition whether you receive a statement or not. If your account becomes 15 days past due, your child's spot will be forfeited and he/ she will not be able to participate until the account is paid in full.
- Payment: Everyone is required to choose one of the following options upon registering for classes: (1) Enroll in our automatic draft payment plan (2) Pay your last month's tuition upon enrollment (please note that the amount required to be held on your account may change as your child changes classes). Those not on our auto-pay plan may submit their payments at the front desk, the payment box located in the observation area or mailed to US Gold, 4000 Haslet-Roanoke Rd. Ste 100, Roanoke, TX 76262. USG accepts cash, checks, money orders, VISA or MasterCard. There will be a returned check charge of \$25.
- **Registration:** There is an annual \$35 registration fee due at the time of enrollment for every child (\$50 per family) who participates in the program. This fee will be automatically billed each year on your anniversary date.
